IDOL File No.: 2027-H-CC08-2368 coming on September 8, 2026, to be heard for initial prehearing conference under the Prevailing Wage Act, 820 ILCS 130/0.01 – 12 (“the Act” or “PWA”), and in accordance with Article 10 of the Illinois Administrative Procedure Act, 5 ILCS 100/10-5 – 10-70 and the procedures stated in the Department of Labor’s Rules at 56 Ill. Admin. Code 120.100, *et seq.*, all parties being on notice, this Administrative Law Judge issues this Order:

IT IS HEREBY ORDERED:

1. The hearing date of September 25, 2026, is stricken as the parties have waived,

both in writing and on the record, any requirement that a hearing on the Objections shall be held within forty-five (45) days of the filing of the Objections under the Act.

5. No further briefing shall be permitted absent leave of the Administrative Law Judge.
