ORDER

IDOL File No.: 2027-H-CC08-2365 coming on September 4, 2026 to be heard for initial prehearing conference under the Prevailing Wage Act, 820 ILCS 130/0.01 – 12 (“the Act” or “PWA”), and in accordance with Article 10 of the Illinois Administrative Procedure Act, 5 ILCS 100/10-5 – 10-70 and the procedures stated in the Department of Labor’s Rules at 56 Ill. Admin. Code 120.100, *et seq.*, all parties being on notice, this Administrative Law Judge issues this Order:

IT IS HEREBY ORDERED:

1. The hearing date of September 25, 2026 is stricken as the parties have waived, both in writing and on the record, any requirement that a hearing on the Objections be held within forty-five (45) days of the filing of the Objections under the Act.
2. All parties have agreed and consent to email service in lieu of messenger or U.S. mail service.

3. Objector(s) shall file its Response to Respondent's September 3, 2026 Motion to Dismiss Objector's Objection and Request for Hearing and Deny Its Request for Extension of Time ("Motion to Dismiss") on or before September 11, 2026, at 5:00 p.m.
4. Respondent(s) shall file any Reply in support of its Motion to Dismiss on or before September 15, 2026, at 5:00 p.m.
5. No further briefing shall be permitted absent leave of the Administrative Law Judge.
6. Pending disposition of Respondent's Motion to Dismiss, consideration of any Petitions to Intervene and further pre-hearing proceedings are held in abeyance. If any portion of the Objections remains pending following disposition of the Motion to Dismiss, the Administrative Law Judge will enter an appropriate order addressing intervention and further proceedings.
7. This matter is set for hearing on Respondent's Motion to Dismiss on September 18, 2026 at 11:30 a.m.
