**THIS MATTER COMING** on to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01-12 and Notice of Hearing issued thereunder; and, Petitioners' April 12, 2018 Motion to Withdraw and Dismiss Objection with Prejudice pursuant to 56 Illinois Administrative Code 120.100-670 all parties having been duly advised on the premises issues this order;

**FINDINGS:**

This matter having been previously dismissed by Motion of Petitioner on October 3, 2017 and subsequently reopened over the objection of Respondent by order on November 7, 2017. The parties participated in a hearing held February 8, 2018. Post-hearing briefs were filed by the parties on March 16, 2018. On April 12, 2018, Petitioner filed its Second Motion to Withdraw and Dismiss Objection with Prejudice.

On April 20, 2018, the undersigned convened a status conference. At the status conference, the parties represented that they had mutually resolved and settled all outstanding issues culminating in an executed written settlement agreement. If Petitioner's Motion was granted, the undersigned indicated clearly to both parties that this matter will not be reopened.

**IT IS HEREBY ORDERED:**

Petitioner's Motion to Withdraw and Dismiss Objection is granted. This matter is dismissed with prejudice
