## **DIRECTOR'S DECISION AND ORDER**

This matter having come before the Illinois Department of Labor after a settlement reached between Petitioners, Mid-Illini Mechanical Contractors Association; Warner Mechanical, LLC; Ruyle Mechanical Services, Inc.; and the PIPCO Companies, Ltd. (collectively, "Petitioners") and Respondents, Joseph Beyer, Director of the Department of Labor ("Director") and the Illinois Department of Labor ("Department") (collectively, "Respondents") concerning the above-captioned action, and the Director having been fully advised of the premises, it is hereby ordered:

1. Respondents shall revise the 2018 prevailing wage rates for the classification of pipefitter working in Peoria County as follows:

These revised rates shall remain in effect for the entire duration of the 2018 rate cycle and may be changed by Respondents only in connection with their recalculation process to determine the 2019 prevailing wage rates or as otherwise required pursuant to Section 9 of the Illinois Prevailing Wage Act (820 ILCS 130/9). Respondents shall make the revised rates effective and publish them on the Department's website on or before October 26, 2018. Any

active public works project on which the prevailing wages have been or will be paid shall abide by the revised rates for hours worked on and after October 26, 2018.

2. Petitioners' petition filed on September 13, 2018, is dismissed with prejudice.
