**ORDER**

**THIS MATTER COMING** on to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01-12 and 56 Illinois Administrative Code 120.130, Notice of Hearing and case management/status conference and Petitioners' Patrick Gleason et. al ("Gleason") Motion to Sever and Consolidate and Potential Intervenors' Petition(s) to Intervene and the parties Agreed Motion to Continue the Hearing; all parties having been duly advised in the premises issues this order;

**Gleason** in case, **2019-H-PK09-2295**, filed objections to prevailing rates the Illinois Department of Labor ("IDOL") established in the **Counties enumerated in the Written Objection and Request for Section 9 Hearing, including Exhibit A in the State of Illinois excluding Cook, DeKalb, DuPage, Grundy, Kane, Kendall, Lake, McHenry and Will for truck drivers involving all classes. Associated General Contractors et al of Illinois et. al ("AGCI")**, case 2019 H-PK-09-2298 have similarly filed an objection involving the same rates, classifications and counties involved in 2019 H-PK-09-2295. Petitioners in both object to Respondents rates

and methodology establishing said rates. Both Petitioners intend to challenge Respondents' rates and methodology.

The two cases raise **common issues and questions of law and fact** because the Petitioners have **challenged identical rates, identical classifications in identical counties.**

56 Ill. Adm. Code 120.310 provides:

In the interest of convenient, expeditious and complete determination of matters, the Administrative Law Judge may consolidate or sever hearing proceedings involving any number or parties or issues and may join or sever parties for the complete administration of justice.

AGCI neither objected nor agreed to Gleason's Motion to Sever and Consolidate, however, AGCI was notified of the Motion by Gleason. AGCI did not file a response objecting to same.

**IT IS HEREBY ORDERD:**

1. Matter **2019-H-PK09-2298** involve objections to prevailing rates Respondents have established in the **Counties enumerated in the Written Objection and Request for Section 9 Hearing, including Exhibit A filed by Gleason in the State of Illinois excluding Cook, DeKalb, DuPage, Grundy, Kane, Kendall, Lake, McHenry and Will for truck drivers involving all classes.** These issues contained in the case of **2019-H-PK09-2295** only are **severed** and **consolidated** into the objection filed in **2019-H-PK09-2298.**
2. The **Petition to Intervene** filed by **Patrick Gleason as member of International Brotherhood of Teamsters, Local 25 et al.** in **2019-H-PK09-2316** is **withdrawn.**
3. The **Written Agreed Motion to Continue the Hearing** scheduled for **January 29, 30 and 31 2019** is **granted.** The hearing dates of **January 29, 30 and 31** are **stricken.** All discovery deadlines, dates and cutoffs, excluding the Petition to Intervene deadline, are stricken.
4. The **telephonic status conference** scheduled on **January 22, 2019** at **11:30 a.m.** will **remain.** At this time, all outstanding issues will be discussed as well as any pending motions. The undersigned will initiate the conference at previously provided attorney phone numbers.
