Code 120.320 (2). Petitions may be filed at DOL.hearings@illinois.gov and must provide notice to Petitioner and Respondent attorneys.
5. **All Petitions to Intervene** shall **comply** with **56 Il. Adm. Code 120.320**.
6. **Failure** to file a **Petition to Intervene** in accordance with 56 Il. Adm. Code 120.320 will result in the Petition **not** being in **compliance** with this **order** and subsequent **denial**.
