CONSENT DECREE

Petitioners, Administrative District Council 1 of Illinois of the International Union of Bricklayers and Allied Craftworkers. AFL-CIO and its Local 21 and Respondents Jane R. Flanagan, Acting Director of the Illinois Department of Labor, and the Illinois Department of Labor ("IDOL"), resolve the above referenced matter pursuant to 56 Ill. Adm. Code 120,540 by entering into this Consent Decree. The parties agree as follows:

- This mater arises under the Illinois Prevailing Wage Act ("IWPA"), as amended, 820 ILCS §130.01 et. seq.
- Petitioners timely filed pursuant to section 9 of the IWPA, objections to the Classifications of Tile Mason, Marble Mason, and Terrazzo Mason (herein "Affected

- Classifications") in the nine (9) Counties of Cook, DeKalb, DuPage, Kane, Lake, McHenry, and Grundy. Will and Kendal County ("Affected Counties") for which the Department published on its official web site prevailing wage rates effective July 15, 2022.
- 3. Pursuant to Section 9 of the Illinois Prevailing Wage Act, the Department issued a Notice of Hearing, scheduled a hearing on Petitioner's Objections, and provided notice to the public of by posting the date, time, location, and other pertinent information regarding the Petitioner's Objections and the hearing on Petitioner's Objections on IDOL's official web site.
- 4. The Department has recognized and has ascertained the prevailing wage rates for the Affected Classifications in the Affected Counties based upon Petitioners' certifications to the Department and the attachments, including collective bargaining agreements submitted. The Petitioner bases its certifications upon collective bargaining agreements entered into between Petitioners and employer associations. The Department has recognized such collective bargaining agreements in ascertaining the prevailing wage for the Affected Classifications in the Affected Counties under Section 4(a) of the Act.
- 5. The parties agree that the Department's published rates for the Affected Classifications in the Affected Counties require technical correction, because the Affected Classification do not reflect the correct and current names of the Affected Classifications, as set forth in the current collective bargaining agreements for covered work performed under this Act.
- Therefore, it is determined that the Classification of Tile Mason shall be changed to Ceramic Tile Layer, the Classification of Marble Mason shall be changed to Marble

Setter, and the Classification of Terrazzo Mason shall be changed to Terrazzo Mechanic, in the Affected Counties, thereby reflecting the current names of the classifications as set forth in the current collective bargaining agreements.

- The Department shall implement and enforce the determination set forth in paragraph 6
 above upon entry of the Consent Decree.
- The Decision and Order disposing of this proceeding shall have the same force and effect as an Order made after a full hearing.
- 9. The parties waive:
 - a. Further procedural steps before the Administrative Law Judge, and
 - b. Any right to challenge or contest the validity of this Consent Decree or the Decision and Order entered in accordance herewith.
- 10. The parties agree that the Consent Decree may be executed in one or more counterparts, all of which shall be considered to be one and the same document binding on all parties hereto, notwithstanding that all parties are not signatories to the same counterpart.
