

WRITTEN OBJECTION AND PETITION FOR HEARING UNDER SECTION 9

The Petitioner, the Downstate Laborers' District Council and its affiliated local Unions (hereinafter referred to as the "Union" or "Petitioner"), by and through its attorney, Tim Ryan, of the Laborers' Midwest Region, submit these written objections to the prevailing rate of wages for the classification of Laborer for both Highway and Building published by the Illinois Department of Labor ("Department") on or about July 15, 2025, and requests a hearing pursuant to Section 9 of the Illinois Prevailing Wage Act (the "Act") to correct the jurisdictional boundaries of its affiliated local unions and to clarify the wages within those boundaries for the published rates. 820 ILSC 4 and 9. Petitioner seeks to clarify the boundaries of its local unions, so they are accurately reflected in the wages on the Department's website which are set forth in Collective Bargaining Agreements. The affected counties include Bond, Clinton, Madison, Monroe, and St. Clair.

OBJECTION - Clarify Geographic Boundaries of the Local Unions Who Have Jurisdiction in The Following Counties: Bond, Clinton, Madison, Monroe, and St. Clair.

- The Petitioner is a labor organization that represents various individuals performing Laborers' work in South Central Illinois with its principal place of business located at 19 Gateway Drive, Collinsville, IL 62234.
- 2. The Department has ascertained the prevailing rate of wages for various trade classifications throughout the State of Illinois including Laborer for Building and Highway.
- The Department has also recognized the classification of Laborer in Building and Highway throughout the State based upon collective bargaining agreements between the Union and various employer associations.
- 4. The Petitioner is submitting this objection because the Petitioner has entered into collective bargaining agreements with various associations and contractors who may be adversely affected if the geographic jurisdiction of the wages is not accurately reflected as they are in the Collective Bargaining Agreements.
- 5. The Petitioner members who are Laborers in the relevant geographical jurisdiction also perform the majority of the prevailing wage work that would be covered by the classification in that area.
- 6. Section 4 of the Act states that;

The prevailing rate of wages paid to individuals covered under this Act shall not be less than the rate that prevails for work of a similar character on public works in the locality in which the work is performed under collective bargaining agreements or understanding between employers or employer associations and bona fide labor organizations relating to each craft or type of worker or mechanic needed to execute the contract or perform such work, and collective bargaining agreements or understandings successor thereto, provided that said employers or members of said employer associations employ at least 30% of the laborers, workers, or mechanics in the same trade or occupation in the locality where the work is being performed. 820 ILCS 130/4(a).

7. Section 9 of the Act, in relevant part, states, "if the prevailing rate of wages is based on a

collective bargaining agreement, the explanation of classes on the prevailing wage schedule shall

be consistent with the classification established under the collective bargaining agreement." 80

ILSC 130/9.

8. The prevailing rate of wages for a Laborer performing the said classification in the relevant

geographical jurisdiction should be based on the CBA between the Petitioner and its affiliated

local unions and associations now in effect and "shall be consistent with the classifications

established under the collective bargaining agreement." 820 ILCS 130/9.

9. The Petitioner respectfully requests that an investigatory hearing be ordered and held in

accordance with Section 4 and 9 of the Act to clarify the geographic jurisdictional boundaries of

its affiliated local unions.

Wherefore, the Petitioner moves the Department to recognize the various geographic boundaries

and to have the wages reflect these geographic boundaries.
