## **ORDER**

THIS MATTER came before the undersigned Administrative Law Judge on September 5, 2025, pursuant to The Prevailing Wage Act, 820 ILCS 130/0.01 – 12 ("the Act" or "PWA"), and in accordance with Article 10 of the Illinois Administrative Procedure Act, 5 ILCS 100/10-5 – 10-70 and the procedures stated in the Department of Labor's Rules at 56 Ill Admin Code 120.100, et seq. The Order further arises out of (1) the status conference held on September 5, 2025; (2) Mid-America Carpenters Regional Council's Motion to Reconsider and Vacate the August 27, 2025 dismissal of its Petition to Intervene; and (3) Mid-America Carpenters Regional Council's Petition to Intervene filed on August 21, 2025.

The Illinois Department of Labor has jurisdiction over the subject matter and the parties pursuant to Section 11a of the Illinois Prevailing Wage Act, 820 ILCS 130, and 56 Ill. Adm. Code §120.400 et seq. Having reviewed the filings, considered the record, and being fully advised in the premises, the undersigned Administrative Law Judge hereby ORDERS as follows:

- 1. Mid-America Carpenters Regional Council's Motion to Reconsider and Vacate the August 27, 2025 dismissal of its Petition to Intervene is hereby GRANTED.
- 2. Mid-America Carpenters Regional Council's Petition to Intervene, filed on August 21, 2025, is hereby GRANTED. Mid-America Carpenters Regional Council is recognized as a party of record with full rights to participate in these proceedings.
- 3. Any and all petitions to intervene shall be filed no later than 5:00 p.m. on September 5, 2025. Any petition to intervene filed after that date and time shall be deemed untimely and will be denied as unduly delaying or prejudicing the adjudication of the rights of the original parties, pursuant to 56 Ill. Adm. Code §120.320(2).
- 4. The telephonic pre-hearing conference set for September 5, 2025, is hereby CONTINUED to September 17, 2025, at 10:00 a.m. The pre-hearing shall address, including but not limited to:
  - a. simplification of issues;
  - b. the necessity or desirability of amending pleadings or documents for clarification, simplification, or limitation;
  - c. stipulations and admissions of fact and the authenticity of documents;
  - d. limiting the number of witnesses;
  - e. the propriety of prior mutual exchange of prepared testimony or exhibits; and
  - f. such other matters as may expedite disposition of the proceedings and ensure a just resolution.
- 5. The Parties, both in writing and verbally, have waived any demand for a hearing within forty-five (45) days of the filing of objections under the Act.

- 6. The undersigned Administrative Law Judge shall initiate the conference call.
- 7. All Parties consent to service by electronic mail. All future filings shall be served simultaneously upon all parties of record and the Administrative Law Judge via email, unless otherwise ordered.
- 8. Failure of any party to comply with this Order, including participation in the continued pre-hearing, may result in appropriate sanctions, including dismissal of objections, denial of intervention, or entry of default, as authorized by 56 Ill. Adm. Code §120.
