Illinois Department of Labor ("IDOL") File No.: 2026-H-RP08-2356 coming on October 23, 2025, to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01 – 12 ("the Act" or "PWA"), and in accordance with Article 10 of the Illinois Administrative Procedure Act, 5 ILCS 100/10-5 – 10-70 and the procedures stated in the Department of Labor's Rules at 56 Ill. Admin. Code 120.100, *et seq.*, the Notice of Hearing issued thereunder, and all parties being on notice during the second pre-hearing conference, the undersigned issues this Order:

IT IS HEREBY ORDERED THAT:

1. All parties have agreed and consent to electronic service in the above captioned matter.
2. No petitions to intervene were filed by 5:00 p.m. on SEPTEMBER 25, 2025 pursuant to the undersigned's September 18, 2025 Order.
3. On the Objector's Motion to continue this matter for 30 days, to which Respondents did not object, the undersigned GRANTED the parties additional time to obtain information and documentation, as well as continue exploring settlement efforts.
4. Accordingly, this matter is set for a third pre-hearing/telephonic **status conference on December 4, 2025 @ 1:00 p.m.** at which time an update on

all matters including settlement status will occur, any pending motions will be handled, and a briefing concerning issuance of third-party subpoenas, exchange of exhibits and any other relevant issues.
