Illinois Department of Labor ("IDOL") File No.: 2026-H-RP08-2356 coming on September 18, 2025, to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01 – 12 ("the Act" or "PWA"), and in accordance with Article 10 of the Illinois Administrative Procedure Act, 5 ILCS 100/10-5 – 10-70 and the procedures stated in the Department of Labor's Rules at 56 Ill. Admin. Code 120.100, *et seq.*, the Notice of Hearing issued thereunder, and all parties being on notice during the pre-hearing conference, the undersigned issues this Order:

**IT IS HEREBY ORDERED THAT:**

1. All petitions to intervene shall comply with 56 Ill. Admin. Code 120.320.
2. Failure to file a timely petition to intervene in accordance with 56 Ill. Admin. Code 120.320 will result in the petition being considered in contravention of this Order and may result in a subsequent denial.
3. **Any and all petitions to intervene shall be filed by 5:00 p.m. on SEPTEMBER 25, 2025.** Any petition to intervene filed after that date and time will be deemed untimely and will unduly delay or prejudice the adjudication of rights of the original parties 56 Ill. Admin. Code 120.320(2).
4. **The hearing date of SEPTEMBER 26, 2025 @ 9:00 a.m. is hereby stricken, in accordance with the parties' timely notification via email to the undersigned, as instructed at today's pre-hearing conference, of the parties' written consent to waive the Act's 45-day hearing requirement.**
5. Accordingly, this matter is set for a pre-hearing/telephonic **status conference on OCTOBER 23, 2025 @ 1:00 p.m.** at which time an update on all matters including settlement status will occur, any pending motions will be handled, and a briefing concerning issuance of third-party subpoenas, exchange of exhibits and any other relevant issues. The undersigned will initiate the call at the numbers previously
