## NOTICE OF PUBLIC HEARING ON PROPOSED RULES Paid Leave for All Workers Act

The hearing will be held for the sole purpose of gathering public comments on the Proposed Rules (47 Ill. Reg. 15559; November 3, 2023) implementing the Paid Leave for All Workers Act (56 Ill. Adm. Code 200). Persons interested in presenting testimony at this hearing are advised that the Department of Labor will adhere to the following procedures in the conduct of the hearing:

- a) Participants wishing to testify should sign up to testify at <a href="https://forms.office.com/g/59x8r6rMqv">https://forms.office.com/g/59x8r6rMqv</a> to sign up prior to the hearing, whether attending virtually or in-person. This is distinct from WebEx registration.
- b) No oral testimony shall exceed an aggregate of 5 minutes for the presentation.
- c) No person will be recognized to speak for a second time until all persons wishing to testify have done so.
- d) Witnesses are encouraged to submit their remarks in writing to <u>DOLPaidLeave@illinois.gov</u> before or after the hearing.
- e) Those individuals who are unable to attend the public hearing but wish to comment on the Proposed Rule should submit written comments on or before December 18, 2023.
