EXECUTIVE SUMMARY

The Illinois Department of Labor (IDOL) Division of Occupational Safety and Health (IL OSHA) submits this State OSHA Annual Report (SOAR) to the federal Occupational Safety and Health Administration (OSHA). The SOAR covers activity from October 1, 2022, through September 30, 2023. This submission is in accordance with federal OSHA Instruction: State Plan Policies and Procedures Manual dated May 6, 2020.

In FY 2023, IL OSHA reduced the number of vacancies that have created problems and challenges in several areas, including past funding deobligations, unmet inspection goals, and failure to complete the final developmental step necessary to become a certified state plan. Authorized staffing levels for the 23(g) program include a Division Chief, two Regional Enforcement Managers, two Consultation Supervisors, one Administrative Assistant, one Office Associate, 11 Public Safety Inspectors, three Industrial Hygienists, two Safety Consultants, two Industrial Hygiene Consultants, an Occupational Safety and Health (OSH) Coordinator, and a Marketing and Outreach Coordinator. At the end of FY 2023, there were only five full-time vacant positions, three Public Safety Inspectors, and two Industrial Hygienists, however one of the three Public Safety Inspectors positions was filled for most of the year. During FY 2023 one Public Safety Inspector was promoted to Regional Enforcement Manager and one Regional Enforcement Manager was promoted to Division Chief. The commitment to fill all vacant positions will continue with a goal to attain state plan certification in calendar year 2024.

During FY 2023, inspectors met 63% of the planned inspections (315 of 500), exceeded the number of planned health inspections (109 of 100), responded to seven work-related fatalities, attended at least one training course each, and trained many employers and employees on critical topics with a focus on “lessons identified become lessons learned.” Additionally, IL OSHA met and, in some instances, exceeded most State Plan Activity Mandated Measures (SAMMs).

In FY 2023 the whistleblower program continued to improve under the supervision of the Division’s Occupational Safety and Health (OSH) Coordinator. The OSH Coordinator has focused on organization and administration of the whistleblower program including a comprehensive update to the Whistleblower Information Manual.

STATE PLAN OVERVIEW

IL OSHA operates a state and local government only developmental state plan. The Division Chief of IL OSHA administers the Illinois State Plan under the leadership of the Director of IDOL. IL OSHA enforces safety and health standards in state and local government workplaces, provides consultation services, investigates occupational safety and health whistleblower complaints, adopts “at least as effective as” federal OSHA standards, and provides outreach services. Federal OSHA enforces private-sector safety and health standards in Illinois.

On September 1, 2009, IDOL received developmental State and Local Government Plan approval (see 74 Fed. Reg. 45114, 2009) to establish all structural elements necessary to be deemed effective. IL OSHA is in the process of completing all developmental steps for final certification.

The constituency covered under the Illinois Occupational Safety and Health Act includes over 8,500 units of state and local government¹ with an estimated 742,351 state and local government employees in Illinois.²

IL OSHA’s organizational structure is on page four. The program continues to further its mission of providing safe and healthful workplaces for all state and local government employees in Illinois through program areas that include:

Administration - Responsible for the overall operation of the IL OSHA program and for policy decisions.

Safety and health compliance - Responsible for safety and health enforcement activities within state and local government establishments/operations.

Safety and health consultation - Responsible for providing safety and health consultation services to state and local government employers (23(g)) and private-sector employers (21(d)).

Standards - Responsible for adoption and distribution of federal OSHA standards.


Discrimination - Responsible for investigation of whistleblower protected activities under section 11(c) of the OSH Act (Section 110 of IL OSH Act) as they relate to state and local government employee discrimination.

Training - Responsible for providing training to state and local government employers and employees, developing training materials, and ensuring safety and health inspectors/consultants are fully trained.

IL OSHA has four public sector employers (an increase of one in FY23) that currently have Safety and Health Achievement Recognition Program (SHARP) status. For FY 2023, the goal was to maintain public sector employers currently in the program with the newest being Effingham Fire Department. In FY 2024, IL OSHA will strive to add one more public sector employer to the program.

To promote state and local government employer and employee awareness of and commitment to safety and health, IL OSHA conducted 45 compliance assistance and outreach activities in FY 2023. Outreach activities such as webinars, conference presentations, press releases, interviews, attendance at events, and informal worksite training resulted in 44,824 outreach participants.

MANDATED ACTIVITES

Activities mandated under the OSHA state plan program are considered core elements of IL OSHA's occupational safety and health program. Mandated activities are tracked on a quarterly basis using the State Activities Measures (SAMMs) Report in OIS which compares state activity data to an established reference point. In FY 2023, IL OSHA met (or exceeded) almost all mandated activity measures.
